A CASE FOR REAL CHANGE

Well it's that time again...We even refer to it as a "season." It is called tax time. I don't think I've ever met anyone who looks forward to this time of year, me included.

This "season" in particular has put the Internal Revenue Service in the spot light yet again. We are all familiar with the scandals surrounding the I.R.S. from possible targeting of conservative groups and the criminal actions to cover up it up. Another scandal includes recent revelations that the I.R.S. issued billions of dollars in potentially fraudulent refunds to criminals involved in organized identity theft operations. During testimony at a Senatorial Hearing, it was stated 2,000 tax returns were sent to one single address. What is most concerning is that the I.R.S. seems to be incapable of stopping the fraud and corruption.

It's no wonder. The I.R.S. is beyond a bloated bureaucracy. Here are some quick facts about the I.R.S.; The I.R.S. code has 3.7 million words. It has 1,977 forms. It employs 95,000 people. Taxpayers are estimated to spend 3.8 billion hours on complying with I.R.S. rules.

We have known for decades that the system of taxation has been compromised and used as a tool by every administration to undermine freedom of speech and manipulate social change. Two words, "I.R.S." and "audit" can send a shiver through the spine of the average taxpayer.
